I further agree to grease the equipment before using it, check the meter reading, **AND USE IMMEDIATELY**, weather permitting. I will store the machine in the dry when not in use.

Any abuse of the equipment will result in additional charges. **IF EQUIPMENT IS KEPT LONGER THAN THE TIME REQUIRED TO USE IT (WEATHER PERMITTING) YOU WILL BE CHARGED AN ADDITIONAL LATE FEE.** Please call the SWCD office at 740-885-3313 for any unscheduled delays. **EQUIPMENT MUST STAY IN WASHINGTON COUNTY.**

You must return the equipment to SEAMAN'S GENERAL MERCHANDISE as soon as you are finished using it. **If you rent a piece of equipment that is covered you will be responsible for returning the cover with the equipment. IF THE COVER IS NOT RETURNED YOU WILL BE RESPONSIBLE FOR PAYING FOR THE COVER PLUS A FEE.**

There will be a 2% interest fee per month if the bill is not paid within 30 days of the billing. After 30 days, the rental equipment will be denied until full payment, including interest, is received by the Washington SWCD. If the bill is not paid within 45 days of the billing it will be turned over to the Prosecuting Attorney. This will be enforced as recommended by the state auditor.
