### Guidelines

Washington Soil & Water Conservation District announces the **2026 Camp Canopy Scholarship**. Under the Program, one (1) \$400 scholarship will be awarded to a Washington County, Ohio student who has completed 8<sup>th</sup> grade through graduation (up to age 19). Camp Canopy is the only place for future foresters and wildlife specialists to get their hands dirty and put their knowledge of forestry and wildlife to the test. Camp Canopy takes place at Ohio FFA Camp Muskingum in Carrollton, OH. This is a week long camp (Sunday –Friday) June 7-12<sup>th</sup>, 2026.
